### Requirements/Procedures/Schedules:

3. A non-refundable deposit of \$200 is due with the application form.
4. New students and parents are given the opportunity to visit prior to registration.
5. A minimum of 6 children is required to offer each class.

New registrants have two weeks upon receipt of the application to register. After that time, applications are received on a first come, first serve basis. Enrollment is limited, so please return the necessary forms and Payment #1 as soon as possible.
